The **General Data Protection Regulation (GDPR)** comes into effect on **25th May 2018**. It will bring higher standards for handling data and greater expectations for improved transparency, enhanced data security and increased accountability for processing personal data. Like all organisations, schools will have a legal duty to comply with the GDPR. Most importantly though, at St. Chad's we believe in the principle of respecting personal data and welcome this opportunity to evaluate and update our policies and practices wherever necessary.

The new GDPR (General Data Protection Regulation) is replacing the current **Data Protection Act (DPA)** and is set to strengthen and unify all data held within an organisation. For schools, GDPR brings a new responsibility to inform parents and stakeholders about how they are using pupils' data and who it is being used by.

The school collects, holds and uses a great deal of information about individuals, particularly pupils and adults connected with the school. Under the GDPR, data about living individuals is known as personal data. The regulation puts in place numerous safeguards for the use of data about individuals.

St. Chad's has a statutory duty to comply with the requirements of the GDPR as it collects data about pupils and adults associated with the school for school business. The school is also required to produce a privacy notice explaining how information is collected and processed. St. Chad's **Privacy Notice**, along with the **Data Protection Policy**, can be viewed on the school website – www.st-chads.lancs.sch.uk

All of the information we hold on individuals follows the six key principles:

- 1) Fair, lawful and transparent;
- 2) Collected for specified, explicit and legitimate purposes;
- 3) Adequate, relevant and limited to what is necessary;
- 4) Accurate, and where necessary, kept up to date;
- 5) Kept in a form which permits identification for no longer than is necessary;
- 6) Processed in a manner that ensures appropriate security.
